Education - The Education Department continued to raise awareness of the atrocities committed against animals within factory farms and the importance of adopting a vegan diet. MFA's education team accomplished this through pro-vegan television ad campaigns; hundreds of leafleting events; tabling at vegetarian, Earth Day, environmental, and other types of festivals and fairs; dozens of humane education presentations; hundreds of "Paid Per View" video screenings; participation in pride parades across the country; and sharing the cruel realities of factory farming and the how-tos of vegan eating with millions of visitors via our educational websites.

4b (Code:) (Expenses \$ **534,072** including grants of \$) (Revenue \$)
Cruelty Investigations - The Investigations Department exposed the cruel practice of force-feeding ducks at Hudson Valley Foie Gras - an Amazon.com foie gras supplier. This painful process causes the birds' livers to swell up to 10 times the normal size. The investigations crew also conducted two investigations at major Walmart pork suppliers. These investigations documented the routine practices of confining pregnant pigs to tiny gestation crates and mutilating piglets without painkillers. MFA's investigation into Wiese Brothers Farms, a dairy operation in Wisconsin that supplied to DiGiorno brand pizza at the time of the investigation, found workers viciously kicking, beating, and whipping cows in the face and body, as well as workers dragging cows by their fragile legs and necks.

Legal Advocacy - The Legal Advocacy Department secured multiple criminal convictions of farmed animal abusers, including in North Carolina and Idaho, which were the subject of an in-depth documentary on the National Geographic Channel. MFA's legal team presented multiple petitions to judges, prosecutors, and sheriffs nationwide, setting the stage for prosecution. The legal advocacy department, in conjunction with a national coalition of animal protection, civil liberties, environmental, labor, and food safety groups, also worked to successfully defeat all 11 whistleblower suppression, or "ag-gag," bills that were introduced in states across the country.
