

The Education Department continued to raise awareness of the atrocities committed against animals on factory farms and the importance of adopting a vegan diet, including tips for making the transition. MFA's education team accomplished this through pro-vegan online ad campaigns; hundreds of leafleting events; tabling at vegetarian, Earth Day, environmental, and other types of festivals and fairs; conducting "Paid-Per-View" video screenings; producing and disseminating viral videos and blog content; and sharing the cruel realities of factory farming and the how-tos of vegan eating with millions of visitors via our educational websites.

The Investigations Department uncovered systemic animal abuse in the poultry industry by conducting investigations into many of the largest poultry producers in North America, including Perdue Farms, Tyson Foods, Foster Farms, Wayne Farms, and Maple Lodge Farms. Video footage from these investigations reveals millions of birds crammed into filthy, windowless sheds before being violently shackled, painfully shocked, cut open, and even scalded alive at the slaughterhouse. An investigation of Seaboard Foods in Colorado exposed workers maliciously hitting and beating pigs. Similar illegal acts of animal abuse were documented at a Dairy Farmers of America member farm in the state.

The Legal Advocacy Department achieved a record number of criminal charges and convictions against factory farms and workers, resulting in the permanent closure of one facility. Along with a coalition of other advocacy groups, the department also defeated the majority of "ag-gag" bills that were introduced. MFA assisted with the historic Massachusetts signature-gathering process to put an anti-confinement measure on the 2016 ballot. MFA's legal team also filed false advertising complaints, shareholder resolutions, and numerous FOIA requests to hold corporations and the government accountable for their obligations under the law.
